- Engaging contractors to slash boundaries and breaks onsite to ensure blocks were achievable in size with the available resources.
- Making fuel reduction a family priority for the property.




The Red Hot Tips team have really enjoyed working alongside Dee over the past year and look forward to continuing to support her - and others like her.

Bushfire Risk Unit

Strategic Bushfire Management Plans

Planning Officers from the Bushfire Risk Unit are preparing Strategic Bushfire Management Plans for several localities across the state. The intent of these plans is to reduce bushfire risk across the designated plan area, and by doing so, reduce the likelihood of bushfire impacts on people, critical infrastructure, environmental values, and other community assets.

The plans are developed to guide and support bushfire mitigation efforts within the area.

They will:

- Identify areas within the landscape where fuel reduction should be prioritised
- Outline strategic mitigation activities to be implemented
- Identify locations where additional fire management infrastructure (fire trails, fuel breaks etc) is required

Strategic Bushfire Management Plans aim to establish a structured, strategic framework that reduces bushfire risk to priority communities and assets through coordinated and proactive bushfire management. The plans take a **tenure-blind approach** meaning implementation will require collaboration by land managers and relevant stakeholders.

By implementing this plan, fire agencies will be better positioned to protect life and property and improve suppression capabilities through:

- Lower potential head fire intensity and radiant heat levels
- Reduced rates of fire spread
- Decreased risk of ember attack
- Reduced likelihood of long-range spotting
- Improved access for fire suppression operations
- Strengthened containment opportunities

The plans identify:

- Defined Fire Management Zones
- Logical Fuel Management Units
- Mapping of Existing Strategic Fire Infrastructure
- Identification of Future Infrastructure
 Requirements

The identification of fire management zones is an important part of the planning process. The zones identify where specific fire management objectives should be achieved to increase protection to priority communities and assets and suppression capabilities. The two types of fire management zones are detailed within Strategic Fire Management Plans:

- Asset Protection Zone
- Strategic Fire Management Zone

Planners form each region will work with local government, land management agencies, utility providers and FRP partner agencies in the development of the plans.

- Flinders Island
- Devonport
- St Helens/Beaumaris
- Hobart Glenorchy
- Wellington Range North
- Wellington Range South
- Margate
- Huonville East
- Bicheno
